Clarification to the Investment Policy for those relevant Funds that make reference to the European Economic Area (“EEA”)

Dear Shareholder,

We are writing to inform you of changes being made to certain Funds of the Company.

On 29 March 2017, the United Kingdom Government gave formal notice of its intention to leave the European Union (“EU”). Under the terms of the relevant EU treaty, the earliest the United Kingdom can leave the EU will be 29 March 2019.

Taking into consideration the possibility that the United Kingdom may cease to be a member state of the European Economic Area (“EEA”) on or after 29 March 2019, the following clarifications will be made to the Prospectus in respect to those relevant Funds that reference the EEA in their Investment Policy. The changes (highlighted below in bold) will be effective from 29 March 2019. The relevant Funds will continue to be managed in the same way.





We are writing to inform you that with effect from 29 March 2019, the Sub-Investment Manager of the Fund will change from Janus Henderson Investors (Singapore) Limited (“JHIS”) to Janus Henderson Investors (Japan) Limited (“JHIJ”).

Currently, Henderson Management S.A., being the Management Company, has further delegated the provision of all investment management discretion in respect of the Funds in the Company to Henderson Global Investors Limited (the “Investment Manager”). The Investment Manager itself then sub-delegates discretionary investment management functions of certain Funds of the Company to sub-investment manager(s). In respect of the Fund, HGIL currently sub-delegates discretionary investment management functions to JHIS.

With the Company’s consent as of the 29 March 2019, the sub-delegation of discretionary investment management functions of the Fund from the Investment Manager to JHIS will cease and instead be replaced by sub-delegation to JHIJ. This appointment has been made in light of the nature of the Fund and with a view to leveraging Janus Henderson’s overall global portfolio management capabilities. It is believed that JHIJ is well positioned to manage the Fund as it is based in the region where the Fund’s portfolio is primarily focused.

JHIJ is in the same group of companies as the Management Company and the Investment Manager. JHIJ is a limited liability company incorporated in Japan and is regulated by the Financial Services Authority in Japan. JHIJ is registered as a Financial Instruments Business Operator conducting type II financial instruments business, investment advisory and agency business, and investment management business in Japan.

The Company confirms that in respect of this change:

- the Fund will continue to be managed in a manner which is in accordance with its existing investment objective and policy;
- the investment objective and policy and the risk profile of the Fund will remain the same;
- there will be no change in the fee level/cost in managing the Fund; and


