管理公司委任案與本公司發行文件修訂生效日資訊之更新

在 2019 年 2 月 22 日所寄發之致股東通知書(下稱「**通知書**」)中,本公司已將提議 委派先機環球投資(歐洲)有限公司(Merian Global Investors (Europe) Limited)(下 稱「**管理公司**」)擔任本公司之 UCITS 管理公司事宜通知本公司股東。此一提案係建 議自管理公司受委任之日起,本公司將成為一家外部管理型之投資公司,且將不再以自 行管理投資公司之形式營運。

提議委任管理公司之緣由主要係為確保在英國脫歐後,本公司擁有一家設立於歐盟之基金管理公司,俾本公司子基金得繼續在歐洲經濟區(EEA)進行銷售。預期在前揭委任案生效後,本公司基金於英國脫歐後仍可由管理公司繼續在歐洲經濟區(EEA)進行跨境銷售。

如通知書所載,前述管理公司委任案原擬自 2019 年 3 月 22 日起或自本公司董事所決定之較晚日期起生效(下稱「生效日」),但由於歐洲理事會(European Council)已展延英國脫歐之最後期限以便英國能有更多時間通過脫歐協議(Withdrawal Agreement,亦即,英國與歐盟間就英國脫歐應如何實施以及英國應如何退出歐盟所簽訂之協議),故本公司董事會認為若將生效日延後至 2019 年 10 月 31 日或本公司董事另行決定之較早或較晚日期,將符合本公司股東之最佳利益。生效日之延後,舉例而言,可能是因設有過渡期,或因政治情勢或法規發展而進一步延後。生效日如有其他變更,將公告於網址 www.merian.com,並將據以通知本公司股東。

Re: Merian Global Investors Series plc (the "Company")

Update on the effective date of the proposed appointment of the management company and amendments to the offering documents of the Company

In a shareholder notice issued on 22nd February, 2019 (the "**Notice**"), shareholders of the Company were notified of the proposed appointment of Merian Global Investors (Europe) Limited (the "**Manager**") as a UCITS management company of the Company. It was proposed that the Company would become an externally managed investment company and would cease to operate as a self-managed investment company upon the appointment of the Manager.

The rationale for the proposed appointment of the Manager is primarily to ensure that the Company has an EU domiciled fund management company, post Brexit, so the sub-funds of the Company can continue to be marketed within the EEA. It is expected that once the proposed appointment has taken effect, the Funds of the Company can continue to be marketed within the EEA on a cross-border basis by the Manager once the United Kingdom has left the EU.

As set out in the Notice, it was intended to effect the appointment of the Manager on 22nd March 2019 or such later date as determined by the directors of the Company (the "Effective Date"). The board of directors of the Company has determined that in light of the extension granted by the European Council to the Brexit deadline in order to allow the United Kingdom additional time to ratify the Withdrawal Agreement, (i.e. the agreement between the United Kingdom and the EU on how to implement Brexit and how the United Kingdom leaves the EU), it would be in the best interests of the shareholders of the Company to delay the Effective Date to 31 October, 2019 or such other earlier or later date as may be determined by the directors of the Company. For example, the Effective Date may be delayed in the event that there is a transitional period or a further delay caused by political or regulatory developments in the interim. Any further changes to the Effective Date will be announced on the website www.merian.com and Shareholders of the Company will be notified accordingly.
