# Important change of Fidelity Funds – Euro Cash Fund and Fidelity Funds – US Dollar Cash Fund Annual Management Fees ("AMF")

### **Key Facts**

- The AMF of Fidelity Funds Euro Cash Fund and Fidelity Funds US Dollar Cash Fund will be lowered from 1<sup>st</sup> April 2021.
- There is no change to the investment objectives or in the manner the Funds are managed as a result of this change.
- There is no need for you to take any further action.

Dear Shareholder,

We would like to inform you that that the AMF of Fidelity Funds - Euro Cash Fund and Fidelity Funds - US Dollar Cash Fund (the "Funds") will be lowered from 1<sup>st</sup> April 2021.

The environment for money market investment disciplines has become increasingly competitive with the lower yield environment. We are therefore reducing the AMF of the Funds in order to reflect this.

There is no change to the investment objectives or in the manner the Funds are managed as a result of this change. This change will have no impact on your holding.
